CDP Private Cloud Data Services includes Management Console, Cloudera Data Warehouse (CDW), Cloudera Machine Learning (CML) and Cloudera Data Engineering (CDE). Learn about the new features and improvements in each of these services.

**Note:**

As of CDP Private Cloud Data Services 1.5.1, external Control Plane metadata databases are no longer supported. New installs require the use of an embedded Control Plane database. Upgrades from CDP Private Cloud Data Services 1.5.0 to 1.5.2 are supported, but there is currently no migration path from a previous external Control Plane database to the embedded database. Upgrades from 1.5.0 with external Control Plane metadata databases also require additional steps, which are described in the CDP Private Cloud Data Services 1.5.2 upgrade topics.
